SATURDAY, MARCH 10 PRE-CONFERENCE WORKSHOP

Case Study #1: A Puzzle of Many Pieces

Speaker: Detective Jeremy Hoffman, Fairfax County Police Department

Between 2011 and 2015, Detective Hoffman targeted members of an online bestiality website for arrest and prosecution. While the overall investigation met with great success, one of the most prominent members of the website in Virginia eluded Hoffman at every turn. Hoffman returned to the case repeatedly until recognizing a fatal flaw that led to the identification and prosecution of Joseph Amley for the sexual abuse of multiple animals. This presentation will cover the large-scale investigation, investigative efforts that failed, and the ultimate success that not only led to the identification of Amley, but identified the loose network of people associated with him who were also abusing animals.

Case Study #2 & #3: Operation Bite Back

Speaker: Mark Barnhart, Special Agent, USDA

In a first-of-its-kind long-term, undercover investigation conducted across 2006-2007 that deeply infiltrated a highly organized dog-fighting enterprise, Special Agent Barnhart conclusively linked other crimes to dog fighting, including drug trafficking, interstate gambling, fraud, and firearms violations. The investigation resulted in 56 Federal and State indictments, the seizures of 62 fighting dogs, and the seizure of property. The case not only had a profound impact on dog fighting both across the United States and internationally, but was specifically cited in Congress during discussions that lead to the increase in criminal penalty from misdemeanor to felony for violations of Animal Welfare Act.

Case Study #4: Zoophilia: When Sexual Deviancy Falls Short of Bestiality

Speaker: Serena Ramirez, Humane Officer, Central California SPCA

In 2016, Humane Officer Ramirez received a complaint from a reporting party regarding the torture of his dog by his partner. Video evidence provided revealed several incidents of torment and bondage. With the assistance of spcaLA, Humane Officers executed a warrant at the apartment of the perpetrator, Mark Grahmann. The suspect pled guilty to felony animal cruelty charges. Officer Ramirez will explore various aspects of this case including warrants dealing with electronics, building the case, and court-mandated psychological examinations.

Capt. Perea will moderate a discussion with Deputy Friedland, Dr. Raines, and Deputy Director Ubario into what is considered to be the largest fighting fowl seizure in US history, involving more than 7,000 illegal birds. In a joint action, that resulted from a months-long investigation into the cockfighting ring by detectives specializing in animal blood sport crimes, Society for the Prevention of Cruelty to Animals Los Angeles (spcaLA) collaborated with the Los Angeles County Sheriff's Department's Blood Sport Crime Team and Los Angeles County Department of Animal Care & Control in the May 2017 operation after a Los Angeles County Sheriff's Department investigation led to a raid at a remote canyon property in northern Los Angeles County.

Field Services & Shelter Medicine: *Whistler Sled Dog Cull*

Officer Drever, Dr. Merck, and Senior Manager Eccles will provide their insights into the infamous Whistler Sled Dog Cull case, which involved the killing of 56 sled dogs in Whistler, British Columbia, Canada, and prompted an investigation by the British Columbia Society for the Prevention of Cruelty to Animals (SPCA) and Royal Canadian Mounted Police. The April 2010 mass killing was committed by Robert Fawcett, an employee of Howling Dog Tours Whistler, Inc., after he was allegedly told to euthanize the dogs because of a downturn in business after the 2010 Winter Olympic Games in Vancouver.

MONDAY, MARCH 12, CONFERENCE SESSION TRACKS

Field Services: *When Dogs Attack*

Speaker: Jamie Simmons, Animal Control Officer, Fontana Police Department

With more than 21 years' experience in her field, Officer Simmons will disseminate a particularly taxing case she worked on that began when a group of five pit bull mix dogs escaped a residence, viciously and critically injuring three children, and ended when jurors delivered seven felony convictions at trial. Rather than the dogs involved being subjected to malicious abuse, instead they had endured years of neglect and isolation. To prove this Simmons' team utilized forensics, a property flyover, as well as bite radius examinations and comparisons. With detailed photos, forensic study reports, and step-by-step details Simmons will show how years of owner irresponsibility resulted in a pack of unsocialized dogs capable of extreme violence.

Field Services: *Out of Control*

Speaker: Chief Steve MacKinnon, Humane Law Enforcement, San Diego Humane Society

Chief MacKinnon will explore a recent residential hoarding investigation involving up to 30 Yorkies that will highlight working with law enforcement agencies and other groups; rescue/recovery challenges; investigative hurdles; shelter issues involving medical, housing, and grooming and media interest.

Field Services, Shelter Management & Shelter Medicine: *Animals and Disasters - What We Have Learned from the Napa and Sonoma Fires*

The scope of the devastating October 2017 wildfires in Northern California was unprecedented. With 44 people killed and more than 243,000 acres burned, the fires caused a reported \$9.4 billion in damage involving the destruction of at least 8,900 structures. Lesser known is the toll those fires took on the region's animal populations, and how thin animal services and resources were stretched in their attempts to provide assistance and care. In this panel discussion, shelter directors, managers and doctors will explore what they saw and learned first-hand.
